

1.0 Welcome address by Principal

At the outset, Principal welcomed Hon'ble Chairman and the members present to the 1st BoG meeting and appraised about Technical Education Quality Improvement Programme (TEQIP) of Ministry of Human Resource

Development, Government of India being implemented as a World Bank assisted Project to improve the quality of technical education system in the country.

Government College of Engineering (GCE), Keonjhar was recipient of TEQIP Phase III for an amount of Rs.10 crores by MHRD, Govt. of India during the project period 2017-2020. TEQIP-III is to be implemented on the basis of the guidelines given in Project Implementation Plan (PIP) of TEQIP-III being monitored by National Project Implementation Unit (NPIU) - a unit of Ministry of Human Resource Development, Government of India, established in August 1990 for coordination, facilitation, monitoring and to provide guidance to the States/ Institutions in all aspects of the projects related to Technical Education. After thread bare discussions held on various matters as given in agenda notes, BoG agreed in principle to follow the guidelines laid by NPIU, MHRD, Govt. of India for execution of the activities under TEQIP- III successfully and the following decisions were taken:

1.3. Ratification of Institutional TEQIP Unit

The Institutional TEQIP Units formed as per the following and basing on the guidelines of TEQIP-III for smooth management of TEQIP-III activities was ratified by BOG:

- (a) Institutional Project Director (IPD): Principal
- (b) Institutional Project Coordinator (IPC) or TEQIP Coordinator: Er. Mukesh Bathre
- (c) Nodal officer (Finance): Er. Dayanidhi Jena
- (d) Nodal officer (Academics): Er. Sushant Kumar Pradhan
- (e) Nodal officer (Procurement): Er. Adiraj Behera

1.4. Ratification of TEQIP-III Purchase Committee at Institute Level

BoG approved the constitution of Purchase Committee as per TEQIP – III guidelines to look after the procurement activities as per procurement plan as follows:

1.5. Ratification of Action Plan for various activities under TEQIP-III submitted to NPIU

Principal appraised to the members of BoG that as sought by NPIU, action plan for various activities of TEQIP-III needs to be uploaded in the portal of NPIU in each quarter of a financial year after due approval of BoG. Since the actual execution of TEQIP-III activities was started from October 2017, an action plan for 2nd guarter (July to September 2018) of the current F.Y 2018-19 have been prepared and submitted to NPIU, which was placed in point 1.4 of the agenda notes for the approval of BoG. BoG agreed and approved it (Annexure-I).

1.6. Approval of the expenditures already incurred for various activities till 28.05.2018 and other planned activities

Principal appraised to the Board that since TEQIP-III has been made operational since July, 2017 and BoG was not formed, some decisions were taken to start activities related to TEQIP-III and these have already been undertaken or planned and expenditures already incurred towards those activities as per point 1.6(a), 1.6(b), 1.6(c), 1.6(d), 1.6(e) and 1.6(f) of the agenda notes. Principal placed the same for approval of BoG. BoG approved the same (Annexure-II). The BoG members remarked that during the preparation of the agenda notes, the expenditures incurred in various activities are to be specified. Also the members stressed that the faculty members who have attended the induction training programme are required to give the training to other faculty members.

1.7. Approval for conducting skill based training classes by CTTC, Bhubaneswar in the college

BoG approved the process of imparting training to the students, faculty and staff in specialized areas under TEQIP-III with the objectives of improving teaching-learning process for enhancing students' skill and employability by the Central Tool Room and Training Centre (CTTC), Bhubaneswar (A Government of India organization under the Department of MSME) as per MoU signed on 10th February 2018. The students will pay 20% of the fee charged by CTTC and the rest 80% will be reimbursed through TEQIP-III grant. The salient points in the MOU are as following.

- CTTC shall impart broad based short term/ medium term/ long term training to the students as per the curriculum designed by CTTC.
- ii. CTTC shall impart specialized training for the faculty improvement program as per the curriculum designed jointly by CTTC and GCE, Keonihar.
- iii. CTTC shall establish the CTTC High Tech Lab by installing required infrastructure like Computers, furniture, Air conditioners etc.
- iv. GCE, Keonjhar shall provide built up space/ Lab space of at least 1000 sqft. to enable CTTC to establish the CTTC High Tech Lab.
- v. CTTC and GCE, Keonjhar shall share the course fees from the students in the ratio of 80:20 respectively towards the training provided in case the training is provided in the CTTC High Tech Lab.
- vi. CTTC and GCE, Keonjhar shall share the course fees from the students in the ratio of 70:30 respectively towards the training provided in case the training is provided in the GCE Lab.

1.8. Any other points with the permission of the chair.

i. The members advised the TEQIP unit to finalize the vendors for imparting soft skill training and GATE coaching to the final year students of all the departments at the earliest so that the same can be provided from the starting of the next academic session through TEQIP funding. The members also observed that the students of 1st year and 2nd year should be given the training on communication skill for which the expenditure is to be sourced from the internal funding. In this regard it is learnt that Government of Odisha has signed a MOU with British Council to impart communication and soft skill training. The BoG authorized the

- Principal to negotiate with them for imparting the same to the 1st and 2nd year students.
- ii. The members observed that only the regular faculty members are being sent for various training programme and remarked that all the faculty members including the contractual faculty members must be sent for induction and other faculty development training.
- iii. The members advised the TEQIP unit to formulate the guidelines for conducting conference/workshop/FDP as per the guidelines of the NPIU.
- iv. The BoG approved appointment of two nonteaching staff for the TEQIP cell of the institute. The remuneration to paid is to be as per the Government guidelines.
- v. The members advised to finalize the process of introduction of biometric attendance system for the students from the coming academic session.
- vi. The Joint Secretary asked to develop a state of art laboratory to be used for the industrial consultancy and research by the faculty members and the chairman suggested to send two faculty members to IIT(ISM), Dhanbad for observing the central instrumentation facility there so that a similar facility can be replicated here.
- vii. The members expressed concern for the poor placement record and asked to ensure that all the students must be sent for the summer internship as per the recent AICTE guidelines.
- viii. The BoG members approved the following infrastructural requirement and advised the Principal to approach the Government for the sanction of Fund.
 - a. Academic Block-V
 - b. Staff Quarters-12 Nos.
 - c. Principal Quarter
 - d. Central Library
 - e. Guest House
- ix. Few non-teaching staff who are working since long in the institute as contractual/DLR met the BoG members. The Principal informed that as posts have not been created till date, their regularization process could not be initiated. The members advised the Principal to prepare a report on the nonteaching and teaching staff requirement and submit the same to the University for onward transmission to the Government for creation of the posts.

- x. The members advised to prepare a guideline for taking up of consultancy work by the faculty members as prevalent in other government colleges.
- xi. The Chairman suggested for compulsory training of Total Station and GPS to Mining and Civil Engineering students as there is a growing demands of man power having this skill set.
- xii. The members suggested to ask the teachers to submit research proposals to be funded under TEQIP.
- xiii. The BoG approved the research proposal submitted by Saswat Kumar Das, 2nd year Civil Engineering on "Geopolymer concrete by Rice Husk Ash (RHA) and Ground Granulated Blast Furnace Slag (GGBS)" to be funded by TEQIP. The approximate cost is about Rs. 25,000/.
- xiv. The members suggested to prepare a report on faculty requirement as per the new AICTE guidelines of STR of 20:1 and submit the proposal to the University for creation of new teaching posts of different departments. In the meantime NPIU may be requested to appoint contractual lecturers for the required faculty positions.

- 1. DECISIONS TAKEN IN THE MEETING HELD ON 17.03.2018 AT 11.00 AM IN THE PRINCIPAL OFFICE FOR DISCUSSION ABOUT THE PAYMENT OF TA/DA BILLS AND OTHER FEES TO THE STUDENTS FOR PARTICIPATING IN THE TECHNICAL FEST/CONFERENCES/SEMINAR /WORKSHOP ETC.
 - i. Only top 25% students of each semester having CGPA > 7.5 participating in different events at IIT/NIT and other institutions, Internship, Training Programs, Online Courses, Workshop etc. will be eligible to get reimbursement of TA and Registration Fees/Course Fees/Training Fees.
 - ii. The students participating in various events are eligible to travel by Bus, Rail (Sleeper Class) and they can produce the bills for reimbursement after returning.
 - iii. The 50% of Registration Fees/Course Fees/Training Fees limited to Maximum Rs. 5000.00 will be reimbursed to the students participated with the prior approval of the HOD of the respective department and the Principal.
 - iv. All the payments related to the TA and Registration Fees/Course Fees/Training Fees are subjected to reimburse on the basis of fund allocation by the respective department. If any department do not allocate fund for the given purpose, then students of that department will not be eligible to get reimbursement of TA and Registration Fees/Course Fees/Training Fees.
 - v. The applications of students and faculties must be forwarded or recommended by the respective HOD to the Principal. The HODs of all the departments are requested to forward application of students and faculties only for the component of TEQIP-III Action Plan for which they have allocated fund in the respective quarter.
 - vi. The HODs of all the departments are also requested to provide equal opportunity to the students and faculties for participating in the various academic activities under TEQIP-III Scheme.
 - vii. In exceptional case, the students who have already participated in the various events (like IIT Kharagpur Tech Fest, Internship, Training Program, Conference etc) with prior approval of the Principal are eligible to get reimbursement of TA and Registration Fees (50% of Registration Fees/Course Fees/Training Fees limited to Maximum Rs. 5000.00).
 - viii. The final/second year students of all the branches will be eligible to get money for their Major/Skill Project work. All the final/second year students will submit their project group application for prior approval through the Project Guide and the HOD of the respective department to the Principal. Maximum Rs. 5000.00 will be reimbursed to each group of students after submission of bills.
 - ix. The bill payments of students (i.e. for participating in various academic activities) will not be transferred directly as it is very difficult to handle the hundreds of students account in the online PFMS system. A new bank account i.e. the account in the name of "Academic Officer, TEQIP-III, GCE, Keonjhar" should be opened which will be used to release the payments of the students. The Academic Officer, TEQIP-III will be responsible to make payments to the students through his account.
