9.1 Welcome address by the Principal and Address by the Chairman, Board of Governors

At the outset, Principal welcomed Hon'ble Chairman and the members present in the 9th BoG meeting and thanked them for attending the meeting. The Chairman, Board of Governors addressed the members present in the meeting and gave his kind consent to start the meetings as per the agenda.

9.2 Approval of Expenditure already incurred after 8th BOG meeting

Principal appraised the Board about various activities and the expenditures from 8th BOG to till date (attached as Annexure-I of the agenda notes) towards quality improvement in Technical Education in the college and placed the same for approval of BOG. The Board approved the same.

9.3 Action plan of the Quarter - 2 (July 2020 to September 2020)

Principal appraised to the members of BOG that as sought by NPIU, action plan for various activities of TEQIP-III needs to be uploaded in the portal of NPIU in each quarter of a financial year. As per requirement of NPIU, the action plan from July 2020 to September 2020 (attached as Annexure II in the agenda notes) has already been uploaded. In the case of restoration funds from NPIU, a revised action plan may be sent including the additional grant. The BOG members went through the action plan and approved it. As there was no academic activity included in the action plan due to absence of students due to Covid-19 pandemic, Prof. Antaryami Mishra, SPA, SPIU asked the Principal to conduct online seminar, webinar and FDP by all the departments and include the same in the academic activities through TEQIP.

9.4 Centre of Excellence by Dassault Systems through Odisha Skill Development Corporation

A representative from Dassault Systems gave a presentation to the Board members on establishment of CoE at our institute in the area of Mining and Mineral engineering. After going through the presentation, the members asked the vendor to submit a detailed project report with the emphasis on applicability of the Centre to the students of our institute, nearby Diploma and ITI institutes and the local industries including the revenue generation model so that it can be self-sustainable in the future. Dr. Subasish Das pointed out that before establishing the CoE in the area of Mining and Mineral

Engineering, the proposal must be studied properly in respect of its effectiveness in improving the skill and employability of the students.

9.5 Centre of excellence on Mining, Mineral and Metallurgy Engineering through DMF

Dr. Ajaya Nayak requested the Principal to resubmit the proposal to DMF through the SDTE department as per the information received from the PMU of DMF.

9.6 Any other points

9.6.1 Development of Course material for 3rd, 5th and 7th semester

Dr. Ajaya Nayak asked the Principal to instruct the faculty members of Mining and Mineral Engineering to start preparing the course material for 3rd, 5th and 7th semester as the regular classes for the students may not be possible due to Covid-19 pandemic situation. The faculty members will be paid Rs. 2000/- per one module, Rs. 1000/- per one set of question paper and Rs. 5000/- per module of Video lecture as per the decision at the Government level. It was also approved to develop one studio for recording of video lecture in the college. These expenditure is to be met from TEQIP grant.
