- (a). Ph. D. degree in relevant field and First class or equivalent at either Bachelor's or Master's level in the relevant branch. (60% marks or 6.75 CGPA in aggregate shall be considered equivalent to First class if First class or Division is not awarded by the concerned institution).

AND

- (b). Minimum of 10 years of experience in teaching / research / industry out of which at least 3 years shall be at a post equivalent to that of an Associate Professor.

AND

- (c). At least 6 research publications at the level of Associate Professor in SCI journals / UGC-CARE / AICTE approved list of journals and at least 2 successful Ph.D. guided as Supervisor / Co-supervisor till the last date of the application.
