**(A) Eligibility for making an application under the scheme:**

- 1) Class XII pass out Students from Jaipur District and enrolled in your Institute in the year 2021 for the academic session 2021-25
- 2) Minimum 70-80% marks in Class XII Board Exam and Rank in the Entrance Exam (OJEE, JEE or any equivalent exam)
- 3) Family income from all sources should not be more than Rs. 3 Lakh per annum during the financial year of the application.
- 4) Either or lost both parents/ earning members due to Covid-19

**(B) Procedure for Applying for the Scholarship:**

- 1) VISA team shall ensure that the application forms along with the eligibility criteria printed on the backside of the form is made available in the office of Principal of the Institute and the list of eligible candidates received from the Institute via email.
- 2) The students may apply for the scholarship by scanning the QR code available on the poster and filling up the application form and uploading the supporting documents.
- 3) The student should fill the application form and email the filled application form along with copy of mark sheet of Class XII Board Exam, Rank in the Entrance Examination (OJEE, JEE), income proof of the Parents, Death Certificate in case of Pandemic affected, Aadhaar Card of Self, Aadhaar card of Parents, Pan Card of Parents (if any), Character Certificate of the student from the last school/college attended, Institute Admission proof, Bank Pass book of the Institute at [corporatecomm@visa-group.com](mailto:corporatecomm@visa-group.com) within 24<sup>th</sup> November 2021.
- 4) All application forms and attached documents must be vetted and approved by the Institute Authority before emailing to VISA Team.
