- Form must be forwarded by the HOD and Principal.
- Only To & Fro TA bills are acceptable for reimbursement.
- Maximum Registration Fee is permissible for Rs.4000/- for attending Internship/Tech fest/Workshop.
- DA & Accommodation Bills are not permissible except accommodation bill shall be reimbursed for attending conference.
- Only original bills are acceptable. In case of group travel, signed photocopy of bill may be acceptable.
- Small bills must be affixed on plain paper in order to avoid missing of these bills.
