The 3rd, and 4th year students who will take admission in Baldev Jew Hall of Residence for the academic session 2026-27 are required to deposited the hostel fee of amount **Rs 54,600/-** (Rupees Fifty-Four Thousand Six Hundred only) **through direct deposit in the bank account of Baldev Jew Hall of Residence starting from Date 1st July to 8th July.** While making the payment, students must clearly mention their Name, Registration Number, and Year of Study in the deposit details. After depositing the hostel fee, all students are required to report physically to the hostel for the admission process. At the time of reporting, students must bring the following documents:

1. Duly filled-in Hostel Admission Form (all columns must be completed).
2. A photocopy of the bank passbook.
3. Payment Slip

Students are advised to ensure that the admission form is filled in completely and correctly. Incomplete forms or forms containing incorrect information may not be accepted.

- Students are requested to fill the admission form and must deposit the same along with payment slip and xerox copy of the bank passbook to the undersigned authority.
- No room will be allotted who will not deposit the full amount. If anybody will stay in the hostel without payment, severe disciplinary action or rustication from hostel will be taken against him.
- Remaining seats will be declared vacant for 3rd semester students on 10-07-26. A separate list of eligible 3rd semester students for admission to BJHR will be published, then only they will pay the required hostel fee.


