




1.3 Prime objective of conducting the event


1.16 Proposal Evaluation


- i. The Technical Proposals submitted on the time & date stipulated in this SHORT TENDER shall be opened, in presence of Bidders who choose to remain present. The name of the Bidders who have submitted their proposals shall be announced.
- ii. Prior to evaluation of proposals submitted, GCE, Keonjhar will determine whether each proposal is responsive to the requirements of the SHORT TENDER. GCE, Keonjhar may, in its sole discretion, reject any proposal that is not responsive hereunder. A proposal shall be considered responsive only if:
 - a) Proposal prepared have been as per the format specified in the SHORT TENDER;
 - b) it is received by the due dates stipulated in the SHORT TENDER including any extension thereof granted by GCE, Keonjhar;

2.1 Objectives of the Assignment

1. Engagement of DJ for 02 nights
2. Engagement of Emcee/ Anchor for 02 nights
3. Performance of Singer of national repute for 01 night
4. Performance by Band group for 01 night
5. Photographers and Videographers for 02 nights to cover these performances





4. EVALUATION CRITERIA

4.1 Evaluation of Proposals

The SHORT TENDER bids of those Bidders which would meet the minimum conditions of eligibility specified in Section 4.1.1, will be evaluated in two stages:

- i. Technical evaluation based on eligibility criteria
- ii. Financial Proposal

4.1.1 Pre-Qualification / Minimum Eligibility Criteria:

- (i) The Bidder must be rendering event management and brand promotion services in same name and style for last **Financial Year: 2024-25** (from the date of submission of bid). Documents like ROC registration, MoA of Company, AoA of Company, PAN, TAN, Service Tax / GST registration, etc. relating to business entity should be furnished, **and**;
- (ii) The Bidder shall be an Income Tax Return of last 1 (one) year, **and**;
- (iii) In last 02 (two) years from the date of submission of bid, the Bidder should have solely undertaken and completed Artist management of minimum **1 (one) artist management event projects** of minimum contract value of **Rs. 10.0 Lakhs** (Rupees Ten lakhs) including GST for each project,

All the projects cited needs to be submitted by supporting credentials (work orders / purchase orders / agreements / completion certificates/email confirmation from official mail ids of the above institutes/Societies/ Statutory Bodies) from clients and;

- (iv) The firm should have a minimum turnover of **Rs. 01 Crore** (Rupees One Crore) in last financial year FY 2024-25. Copies of the audited financial accounts of **last Financial Year:2024-25** should be furnished along with a certificate from Chartered Accountant certifying the turnover of the Bidder from event management work as per prescribed format in Annexure - A3.
- (v) The Bidder should not have been black-listed by any Central or State Government(s) / Public Sector Undertaking.

4.1.2 Technical Proposal Evaluation – All bidders, who shall meet the eligibility criteria will be deemed as technically qualify for opening of financial bid.

Note: The project should have been undertaken by the Agency in the last 02 (two) Years from the date of submission of bid.

Any single Project having minimum 02 (two) times of the Estimated Ceiling Value i.e 20 (Twenty) lakhs including GST or more meeting the following criteria:

4.1.4 Opening of Financial Proposal:

The financial proposal of those bidders qualified in evaluation of technical proposal shall be opened and evaluated in presence of such bidders on L1 basis.

- a. The decision of GCE, Keonjhar as regards to acceptance/rejection of eligibility for parties who apply shall be final and binding.
- b. Notwithstanding the above, GCE, Keonjhar reserves the right to accept or reject any or all bids or to annul the bidding process.

4.2 After the contract has been successfully negotiated, Preferred Agency will be issued Letter of Intent by GCE, Keonjhar. If the negotiations do not reach any conclusions and if the first Preferred Agency withdraws his proposal, GCE, Keonjhar may then invite Second Best Bidder.

4.4 The other Bidders, which did not meet the Minimum Eligibility Conditions or not shortlisted for other stages of evaluation, or also the Bidders who were technically qualified but were not selected except the second best Bidder, will be informed by GCE, Keonjhar that they were unsuccessful. The Bid Security of such Bidders will be refunded within 15 days after issue of LOI to the successful Bidder.

4.5 No information on the evaluation proposal will be disclosed to any person other than those directly concerned with the selection process. Proposals of any Bidder, who tries to influence the evaluation, will be liable to be rejected.

4.6 Performance Security

The successful bidder shall deposit a performance security equal to 5 (five)% of the awarded contract value in the form of a Bank Guarantee or Demand Draft drawn in favor of **Principal, GCE, Keonjhar**. The Successful bidder shall deposit it with GCE, Keonjhar within 05 (five) days of getting the Letter of Intent.






